

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, MAY 8, 2018**, upon the application of **MAXIMUS OPERATING, LTD.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Travis Peak Zone**, in the Greenwood-Waskom Field, Caddo Parish, Louisiana.

1. To permit the applicant, Maximus Operating, Ltd, to designate and utilize the Maximus Vallhonrat No. 2 Well as the alternate unit well for TP SU99, at the location shown on the plat submitted with the application, which is in compliance with the spacing provisions of Office of Conservation Order No. 270-152, effective August 8, 2017.
2. To find that the proposed alternate unit well is necessary to efficiently and economically drain reserves from the Travis Peak Zone which cannot be economically and efficiently recovered by any existing wells within such unit.
3. To permit the unit operator, Maximus Operating, LTD to produce the unit allowable for the Travis Peak Zone from the unit well, the alternate unit well, or both wells, at its discretion.
4. Except to the extent contrary herewith, to continue in full force and effect the provisions of Order No. 270-152, effective August 8, 2017, and all applicable Statewide Orders.
5. To consider such other matters as may be pertinent.

The Travis Peak Zone was previously defined in Order No. 270-152, effective August 8, 2017.
