At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Davis "B" Sand, Reservoir A, in the Bear Creek Field, Bienville Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Davis "B" Sand, Reservoir A.

2. To create a drilling and production unit for the exploration and production of gas and condensate from the Davis "B" Sand such proposed unit being shown on the plat submitted with the application and being designated Reservoir A.

3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis.

4. To provide that the Commissioner of Conservation may reclassify the reservoirs by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted, based on evidence furnished to the Commissioner of Conservation.

5. To consider such other matters as may be pertinent.

The Davis "B" Sand is hereby defined as that gas and condensate bearing interval encountered between the electric log depths of 8,265' and 8,302' in the Maximus Operating, Ltd.-Southern Natural Gas Fee No. 2 Well (SN 168780), located in Section 13, Township 16 North, Range 6 West.

A plat is available for inspection in the Office of Conservation in Baton Rouge and Shreveport, Louisiana.
