Notice is hereby given on behalf of **Maximus Operating, Ltd.** ("Applicant") of the intention to apply for a public hearing to consider evidence relative to the issuance of an order pertaining to the following matters relating to the Davis "B" Sand, Reservoir A, Bear Creek Field, Bienville Parish, Louisiana:

Davis "B" Sand RA SU A

- 1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Davis "B" Sand, Reservoir A, Bear Creek Field, Bienville Parish, Louisiana.
- 2. To create a drilling and production unit for the exploration and production of gas and condensate from the Davis "B" Sand such proposed unit being shown on the attached plat and being designated Reservoir A.
- 3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis.
- 4. To provide that the Commissioner of Conservation may reclassify the reservoirs by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted based on evidence furnished to the Commissioner.
- 5. The Davis "B" Sand is hereby defined as that gas and condensate bearing interval encountered between the electric log depths of 8,265 feet and 8,302 feet in the Southern Natural Gas Fee No. 2 well, (s/n 168780), located in Section 13, Township 16 North, Range 6 West, Bear Creek Field, Bienville Parish, Louisiana.
- 6. To consider such other matters as may be pertinent.

Pertinent data concerning this intended application is available for inspection at the office of Bryan S. Groves, 110 Oil Center Drive, Live Oak Building, Lobby "A", Lafayette, Louisiana 70503. If any of these parties desire to confer with the Applicant concerning this proposal, they are hereby requested to so notify me within ten (10) calendar days after the date of this letter. In the event I am notified of the desire of any of the parties to confer concerning this proposal, a conference will be held at 1:30 p.m. on Thursday, May 17, 2018, in Energy Room B, 15th Floor, Shreveport Petroleum Club (318) 425-4251 located at 416 Travis St., Shreveport, Louisiana. If no timely request for a conference is received, no conference will be held.
