Dear Commissioner leyoub:

Application is hereby made on behalf of **Maximus Operating, LTD**, for the calling of a public hearing after (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters related to the below described sands and reservoirs in the Greenwood-Waskom Field, Caddo Parish, Louisiana, for which rules and regulations were established for drilling and producing units created by Office of Conservation Orders as shown below.

Travis Peak Zone, Order No. 270-152, Effective Date August 8, 2017

- 1. To permit the applicant, **Maximus Operating, LTD**, to designate, and utilize the Maximus Vallhonrat No. 2 Well (not yet permitted) as the **alternate unit well** for the unit designated, Travis Peak Zone, at the location shown on the plat attached hereto and made a part hereof, which is in compliance with the spacing provisions of Office of Conservation Order No. 270-152, Effective Date August 8, 2017;
- 2. To find that the proposed alternate unit well is necessary to economically and efficiently drain reserves from the Travis Peak Zone which cannot be economically and efficiently recovered by any existing wells within such unit;
- 3. To permit the unit operator, **Maximus Operating, LTD**, to produce the unit allowable for the Travis Peak Zone from the unit well, the alternate unit well, or both wells, at its discretion:
- 4. Except to the extent contrary herewith, to continue in full force and effect the provisions of Office of Conservation Order Order No. 270-152, Effective Date August 8, 2017, and all applicable Statewide Orders and,

5. To consider such other matters as may be pertinent to this application as shown by the evidence presented at the public hearing.

The Travis Peak Zone, in the Greedwood-Waskom Field, Caddo Parish, Louisiana, was previously defined in Office of Conservation Order Order No. 270-152, Effective Date August 8, 2017.

There are attached hereto and made a part hereof a plat which outlines the Travis Peak Zone and reflects the location of the alternate unit well. There is also attached hereto a list of the names and addresses of the Interested Owners, Represented Parties, and Interested Parties to whom this proposal is being sent. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished ONLY to the Commissioner of Conservation and the District Manager of the Lafayette District of the Office of Conservation. However, the list of parties will be provided to any party requesting a copy of it. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties, and Interested Parties.

Finally there is enclosed our check in the sum of \$755.00 payable to the Office of Conservation, representing the required hearing application fee.
