ORDER NO. 270-153

Order concerning permission to drill, designate and utilize an alternate unit well for **TP SU99**, in the **GREENWOOD-WASKOM FIELD**, Caddo Parish, Louisiana.

Pursuant to power delegated under the laws of the State of Louisiana, and particularly Title 30 of the Louisiana Revised Statutes of 1950, and after a public hearing held under **Docket No. 18-268** in Baton Rouge, Louisiana, on **May 8, 2018**, upon the application of **MAXIMUS OPERATING, LTD**, following legal publication of notice and notice in accordance with the Louisiana Administrative Code Title 43 Part XIX, Subpart 17, Chapter 39 as prescribed by the Commissioner of Conservation, the following Order is issued and promulgated by the Commissioner of Conservation as being reasonably necessary to conserve the natural resources of the State, to prevent waste as defined by law, to avoid the drilling of unnecessary wells, and otherwise to carry out the provisions of the laws of this State.

DEFINITION

The Travis Peak Zone, Reservoir A, in the Greenwood-Waskom Field, Caddo Parish, Louisiana, was originally defined in Office of Conservation Order No. 125-A, effective August 1, 1947, and was further defined in Office of Conservation Order No. 270-152, effective August 8, 2017.

FINDINGS

The Commissioner of Conservation finds as follows:

1. That Office of Conservation Order No. 270-1, effective August 1, 1954, as amended and supplemented by the 270 Series of Orders, established rules and regulations and created drilling and production units for the exploration for and production of gas and condensate from the Travis Peak Zone in the Greenwood-Waskom Field, Caddo Parish, Louisiana, including the unit designated TP SU99.

2. That the available geological, engineering or other appropriate information indicates that it would be reasonable and in the interest of conservation to permit the applicant to drill, designate and utilize an alternate unit well for TP SU99, at the location shown on the plat labeled, "Maximus Operating, LTD – Exhibit No. 3 for Docket No. 18-268", a copy of which is attached hereto.

3. That the available geological, engineering or other appropriate information indicates that the proposed alternate unit well is necessary and in the interest of conservation and will drain a portion of the Travis Peak Zone, underlying TP SU99, which cannot be efficiently and economically drained by any existing well.

4. That the unit operator, Maximus Operating, LTD, should be permitted to produce the unit allowable for TP SU99 from either the unit well, the alternate unit well, or any combination thereof, at the discretion of the operator.

ORDER

NOW, THEREFORE, IT IS ORDERED THAT:

1. The applicant, Maximus Operating, LTD, be and is hereby authorized to drill, designate and utilize the Maximus Operating, LTD-Maximus Vallhonrat No. 2 Well as an alternate unit well for TP SU99, at the location shown on the plat labeled, "Maximus Operating, LTD – Exhibit No. 3 for Docket No. 18-268", a copy of which is attached hereto and made a part hereof.

2. The operator of TP SU99 is hereby authorized to produce the unit allowable in accordance with Finding No. 4 hereof.

3. Except to the extent contrary herewith, the provisions of Office of Conservation Order No. 270-1, effective August 1, 1954, as amended and supplemented by the 270 Series of Orders, and all applicable Statewide Orders, shall remain in full force and effect.

This Order shall be effective on and after May 8, 2018.

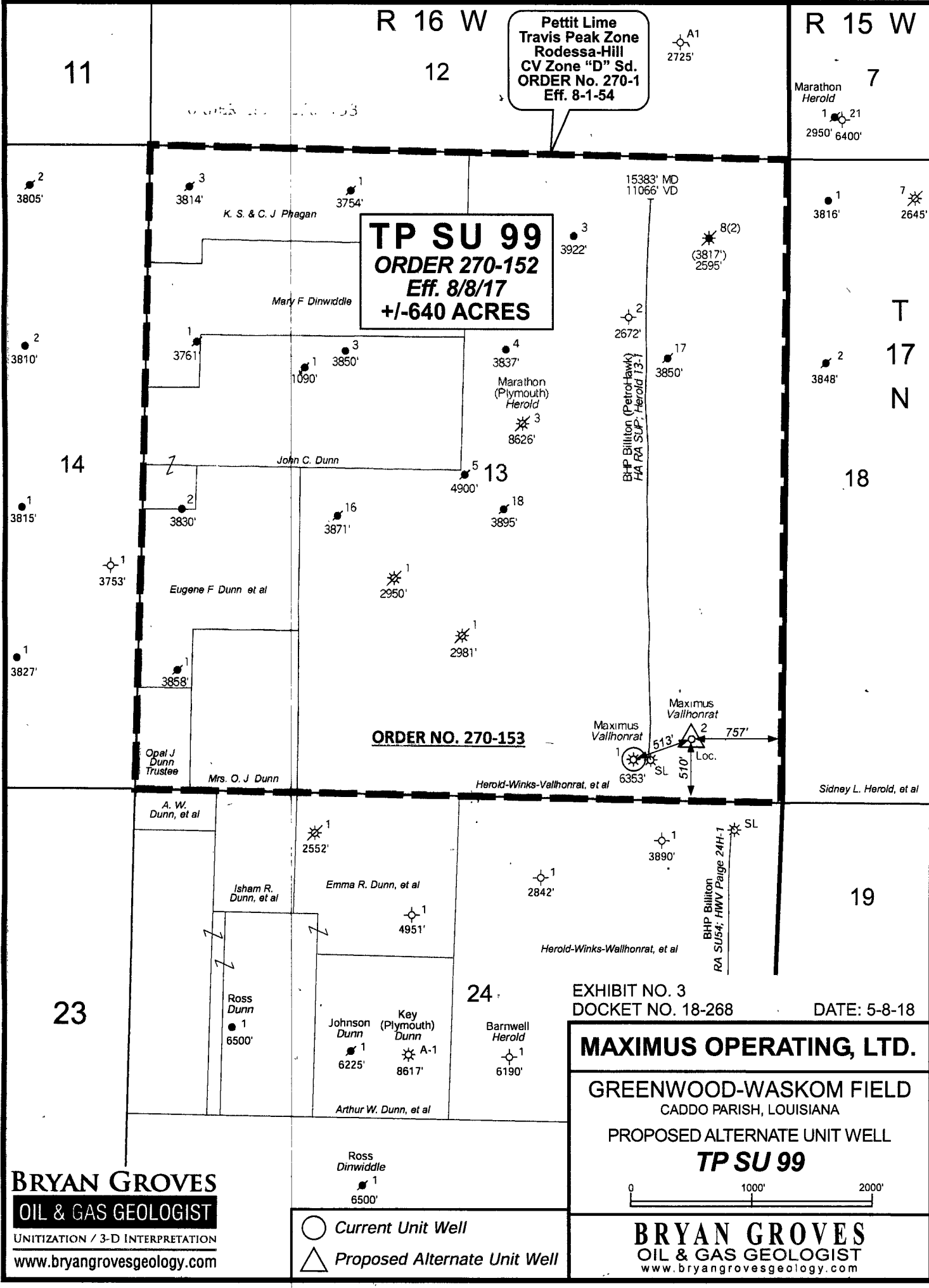

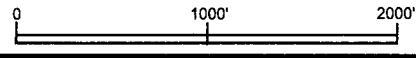
