Application is hereby made on behalf of Excalibur Land Company ("Applicant") to the Commissioner of Conservation for the calling of a public hearing, after legal notice, pertaining to the following matters relative to the Cam 1-2 Zone, Reservoir A, in the Holmwood Field, Calcasieu Parish, Louisiana:

- 1. To establish rules and regulations governing the exploration for and production of oil and gas from the Cam 1-2 Zone, Reservoir A, in the Holmwood Field, Calcasieu Parish, Louisiana.
- 2. To create a drilling and production unit for the exploration for and production of oil and gas from the Cam 1-2 Zone, such proposed unit being shown on the attached plat and being designated Cam 1-2 Zone, RA SUA.
- 3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis.
- 4. To exempt any wells located in the Cam 1-2 Zone, Reservoir A, SUA in the Holmwood Field, Calcasieu Parish, Louisiana, from the spacing requirements of Statewide Order No. 29-E.
- 5. To provide that the Commissioner of Conservation may reclassify the reservoirs by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted based on evidence furnished to the Commissioner.

The Cam 1-2 Zone, Reservoir A, is hereby defined as that oil and gas bearing zone located between the depths of 10,034' and 10,485' (electric log measurements) in the Sohio Petroleum Company – W.E. Walker No. 1 Well (Serial No. 32994) located in Section 26, Township 10 South, Range 7 West, Calcasieu Parish, Louisiana.

A conference to discuss the proposed application was held at 10:00 a.m. on Thursday, December 13, 2018, at the offices of Randazzo, Giglio & Bailey, LLC in Lafayette, Louisiana. The Pre-Application Conference was opened by the undersigned, who explained the purpose and intent of the conference and then the undersigned introduced Mr. Bryan Groves who presented the detailed geologic and other bases for the Applicant's proposed unit; and, advised the attendees the Applicant intended to revise its proposed unit interval definition to include the Camerina 1 sand as well as the Camerina 2 sand since the Camerina 1 sand reservoir lies entirely within the Camerina 2 sand reservoir exterior limits. The Applicant's pre-application conference was held in conjunction with, and immediately following, the pre-application conference of C6 Operating, LLC ("C6") for C6's proposed MARG-CAM Zone, Reservoir A, Sand Unit A, in the Holmwood Field. Mr. Matthew Randazzo, Esq., opened C6's pre-application conference and C6's consultant, Mr. Remy Williams, presented the detailed geologic and other bases for C6's Following Mr. Williams' presentation, Mr. Randazzo asked if anyone in attendance wanted to present a counter-plan. Mr. David Sturlese, a consulting unitization geologist representing the Harrington family, presented a counterplan proposal to unitize solely the Cam 2 Sand within a unit containing approximately 39 acres. No other counterplans were presented during C6's pre-application conference. Upon conclusion of Mr. Groves' presentation on behalf of the Applicant, the undersigned inquired as to whether anyone wanted to present a counterplan. No additional counterplans were presented, but Mr. Sturlese noted the counterplan he presented following C6's presentation is applicable to the Applicant's unit proposal and then the pre-application conference was concluded.

Enclosed and made a part hereof is a plat of the proposed unit for the Cam 1-2 Zone, Reservoir A, Sand Unit A, in the Holmwood Field, Calcasieu Parish, Louisiana. The enclosed plat differs slightly from the plat attached to the Applicant's pre-application notice as explained and discussed at the pre-application conference, including revision of the proposed unit nomenclature from "Cam 2 RA SUA" to "Cam 1-2 RA SUA" as shown on the plat attached hereto and incorporated herein by reference.

Also enclosed to the Commissioner of Conservation and District Manager **ONLY** is a list of Interested Owners, Interested Parties and Represented Parties, and a copy of the List of Conference Attendees to whom a copy of this application is being sent. A reasonable effort has been made to ascertain the names and addresses of all Interested Owners, Interested Parties and Represented Parties. Copies of the list(s) will be provided upon request.
