EBR Louisiana, LLC Frio Zone, Reservoir A

Northeast Iowa Field Area, Jefferson Davis Parish, Louisiana

Notice is hereby given on behalf of **EBR Louisiana**. **LLC** ("Applicant") of the intention to apply for a public hearing to consider evidence relative to the issuance of an order pertaining to the following matters relating to the Frio Zone, Reservoir A, Northeast Iowa Field, Jefferson Davis Parish, Louisiana:

## Frio Zone, Reservoir A

- 1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Frio Zone, Reservoir A, in Northeast Iowa Field, Jefferson Davis Parish, Louisiana.
- 2. To create a drilling and production unit for the exploration and production of gas and condensate from the Frio Zone such proposed unit being shown on the attached plat and being designated F RA SUA.
- 3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis.
- 4. To provide that the Commissioner of Conservation may reclassify the reservoirs by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted based on evidence furnished to the Commissioner.
- 5. The Frio Zone is hereby defined as that gas and condensate bearing interval encountered between the electric log depths of 8,970 feet and 11,950 feet in the Magnolia Petroleum Company Powell Lumber Co. No. C-1 Well (Serial No. 48350), located in Section 31, Township 8 South, Range 6 West, Northeast lowa Field, Jefferson Davis Parish, Louisiana. The Frio Zone has been previously defined and adopted under Order No. 39-X, effective August 19, 2008, in lowa Field in the Magnolia Petroleum Company Powell Lumber Co. No. C-1 Well located in Section 31, Township 8 South, Range 6 West, Jefferson Davis Parish, La., as the stratigraphic interval encountered between the depths of 8,970 feet and 11,950 feet (electrical log measurements).
- 6. To consider such other matters as may be pertinent.

Pertinent data concerning this intended application is available for inspection at the office of Bryan S. Groves, 110 Oil Center Drive, Live Oak Building, Lobby "A", Lafayette, Louisiana 70503. A copy of any such data which is not otherwise available at the Office of Conservation can be obtained from Applicant at the expense of the requesting party.

Pursuant to the Revised Rules of Procedure, Applicant has made a reasonable effort to obtain the names and addresses of all Interested Owners, Represented Parties and Interested Parties to whom this notice of this intended application is being sent and has attached hereto a list of the names and addresses of such parties. A copy of the unit plat is enclosed herewith and a copy of this letter and of the attached plat is being sent to the District Manager of the Lafayette District of the Office of Conservation and to the Interested Owners, Represented Parties and Interested Parties as shown on said list. If any of these parties desire to confer with the Applicant concerning this proposal, they are hereby requested to so notify me within ten (10) calendar days after the date of this letter. In the event I am notified of the desire of any of the parties to confer concerning this proposal, a conference will be held at 10:00 a.m. on Monday, May 15, 2017, at the Lafayette Petroleum Club (337/232-2582) located at 111 Heymann Blvd., Lafayette Louisiana. If no timely request for a conference is received, no conference will be held.
