APPLICANT: TEJAS VIEJO LAND COMPANY

Miocene Zone, Reservoir B

West Gueydan Field, Vermilion Parish, Louisiana

Dear Sir:

Application is hereby made on behalf of **Tejas Viejo Land Company** ("Applicant") for a public hearing to consider evidence relative to the issuance of an order pertaining to the following matters relating to the Miocene Zone, Reservoir B, West Gueydan Field, Vermilion Parish, Louisiana:

Miocene Zone, Reservoir B

- 1. To establish rules and regulations governing the exploration for and production of oil and gas from the MIO RB SU A, West Gueydan Field, Vermilion Parish, Louisiana.
- 2. To create a drilling and production unit for the exploration and production of oil and gas from the Miocene Zone such proposed unit being shown on the attached plat and being designated Reservoir B.
- 3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis.
- 4. To provide that the Commissioner of Conservation may reclassify the reservoirs by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted based on evidence furnished to the Commissioner.
- 5. The Miocene Zone is hereby defined as that oil and gas bearing interval encountered between the electric log depths of 5,960 feet and 11,135 feet in the Magnolia Petroleum Co. Cormier No. 3, (s/n 29979), located in Section 5, Township 12 South, Range 2 West, West Gueydan Field, Vermilion Parish, Louisiana.
- 6. To consider such other matters as may be pertinent.

A conference was held on Thursday, November 16, 2017, at the Lafayette Petroleum Club located at 111 Heymann Blvd., Lafayette Louisiana. On behalf of Tejas Viejo Land Company, I opened the meeting and explained our unit proposal. Questions were asked and answered. A counter plan was displayed on behalf of Walker Properties/CKX Lands, Inc. (represented by Mr. Tom Stewart, but he was unable to attend the conference). The Walker/CKX plan extends the north boundary of our proposed Reservoir B unit to the north. It is unknown if there will be opposition at the hearing.

Pursuant to the Revised Rules of Procedure, Applicant has made a reasonable effort to obtain the names and addresses of all Interested Owners, Represented Parties and Interested Parties to who notice of this application is being sent and has attached hereto a list of the names and addresses of such parties. A copy of the unit plat is enclosed herewith and a copy of this letter and of the attached plat is being sent to the District Manager of the Lafayette District of the Office of Conservation and to the Interested Owners, Represented Parties and Interested Parties as shown on the attached list.

Applicant will provide for posting of a copy of the Legal Notice of this hearing and the enclosed plat at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of the Subject Field, all in accordance with the Revised Rules of Procedure. Furthermore, a copy of the Legal Notice will be mailed to all Interested Owners, Represented Parties and Interested parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, we enclose our check **payable to the Office of Conservation** in the amount of \$755.00 for the application fee.


