**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, APRIL 10, 2018**, upon the application of **EXTEX OPERATING COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Miocene Zone, Reservoir A**, in the West Gueydan Field, Vermilion Parish, Louisiana.

1. To permit the applicant, Extex Operating Company, to designate and utilize the Extex Operating Co., Ferguson No. 10 Well (SN 215091) as the 1<sup>st</sup> alternate unit well for the unit designated, Miocene Zone, RA SUA, at the location shown on the plat submitted with the application, which is in compliance with the spacing provisions of Office of Conservation Order No. 52-FF-1, effective January 9, 2018.
2. To permit the applicant, Extex Operating Company, to drill, designate and utilize the Extex Operating Co., Ferguson No. 9 Well (SN 202978) as the 2<sup>nd</sup> alternate unit well for the unit designated, Miocene Zone, RA SUA, at the location shown on the plat submitted with the application, which is in compliance with the spacing provisions of Order No. 52-FF-1, effective January 9, 2018.
3. To find that the proposed 1<sup>st</sup> and 2<sup>nd</sup> alternate unit wells are necessary to economically and efficiently drain reserves from the Miocene Zone, RA SUA which cannot be economically and efficiently recovered by any existing wells within such unit.
4. To permit the unit operator, Extex Operating Company, to produce the unit allowable for the Miocene Zone, RA SUA from the unit well, the 1<sup>st</sup> alternate unit well, the 2<sup>nd</sup> alternate unit well, or all wells, at its discretion.
5. Except to the extent contrary herewith, to continue in full force and effect the provisions of Order No. 52-FF-1, effective January 9, 2018, and all applicable Statewide Orders.
6. To consider such other matters as may be pertinent.

The Miocene Zone, Reservoir A, SUA was previously defined in Order No. 52-FF-1, effective January 9, 2018.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
