At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hackberry Zone**, **Reservoir L**, in the Starks Field, Calcasieu Parish, Louisiana.

- 1. To establish rules and regulations governing the exploration for and production of oil and gas from the Hackberry Zone, Reservoir L.
- 2. To create a drilling and production unit for the exploration and production of oil and gas from the Hackberry Zone, Reservoir L.
- 3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis.
- 4. To provide that the Commissioner of Conservation may reclassify the reservoirs by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted based on evidence furnished to the Commissioner of Conservation.
- 5. To consider such other matters as may be pertinent.

The Hackberry Zone is hereby defined as that oil and gas bearing interval encountered between the electric log depths of 7,630' and 8,344' in the Crawford Energy Operating Co., Walter No. 1 (SN 232151), located in Section 14, Township 9 South, Range 13 West.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
